What is "SPRAR"?

The Protection System for Asylum Seekers and Refugees (SPRAR) is the Italian network for reception and integration of people seeking and granted international protection



SPRAR - How does it work?

The Italian reception system is based on the

Ministry of Interior

ANCI-National Association of Italian Municipalities

Local authorities with the involvement of the so-called Third Sector (NGO's, associations)

Our history

The Immigration law n.189/2002 (so-called *Bossi-Fini Law*), on the base of a previous and successful experimental project, established:

The Protection System for Asylum Seekers and Refugees - SPRAR

The Central Service of SPRAR

The Fondo nazionale per le politiche e i servizi per l'asilo (FNPSA) –

The National Fund for Asylum Policies and Services





The Central Service (Servizio centrale)

Established by art. 32 of Law 189/2002 and activated by the Ministry of Interior, a convention entrusts its management to ANCI

SPRAR is responsible for the coordination

and the technical support of activities linked to the local projects of reception



The Central Service's Tasks

Central Service's tasks:

Managing of the national data bank

Monitoring of the activities locally undertaken for asylum seekers and refugees

Providing technical assistance and consultancy to local projects, including setting up services, operators training and monitoring of projects' quality standards with regard to Sprar guidelines

Supporting for information and awareness-raising activities



Integrated reception programme NOT ONLY food and shelter provision

Personalized socio-economical project for each beneficiary

Social, psychological and legal assistance and information

Awareness/Information campaigns at local level

Local networks



SPRAR

- The System has been improved gradually, although not as much as needed
- In the last three years the system has grown: from 3.000
- to the current 27.089 reception places



Key words of SPRAR



Key words of SPRAR: Public nature

•Public nature of both the resources made available and of the bodies that are politically responsible for providing reception - Ministry of Interior and local authorities according to the multilevel governance approach



Key words of SPRAR: Synergies

•Synergies, started on the territory with the "managing bodies", third sector players — associations. NGOs, cooperatives — that offer an instrumental contribution to the implementation of the interventions



Key words of SPRAR: Decentralization

•Decentralization of "integrated reception" actions, carried out across the national territory with a presence in all the Regions (except for Valle d'Aosta)



Key words of SPRAR: Local networks

Local networks – stable, solid, interactive

 promoted and developed with the
 involvement of all players and special
 interlocutors for the success of the
 reception, protection and social inclusion
 measures adopted



Key words of SPRAR: Specific skills

•Specific skills of operators, strengthened over the years by in-the-field experience, by training and updating, ensured also at the central level



Key words of SPRAR: Voluntary nature

•Voluntary nature of the local authorities' participation in the network of projects for reception, bearing witness to the political engagement by the local administrations in choosing to plan the interventions to be carried out in their territory of competence in favour of asylum seekers and refugees
